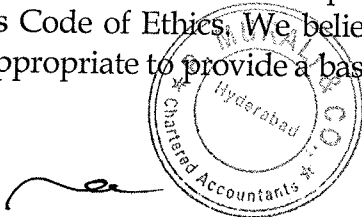
Opinion
